Our Life Books are typically for private circulation. If the Author opts for public publication, a direct link to an Amazon Bookstore page will be provided. The Author will receive 50% of residual sales paid annually.

3. Project Timeline

The project starts when payment is made and the first interview is conducted. We aim to complete the project within three months, though delays may occur due to unforeseen circumstances. The Author is responsible for staying available for reviews and approvals to meet the project schedule. Offices will be closed from December 15th through January 5th and on all major holidays.

4. Fees and Payment

The Author is liable for the agreed fees, which may be paid upfront or in installments. Any outstanding balance must be paid before printing. Additional services like extra pages or interviews will incur extra fees.

5. Cancellation and Suspension

Once the deposit is made and the project begins, all sales are final and no refunds are offered. We reserve the right to cancel or suspend the project under certain circumstances, such as non-payment or unavailability of the Author.

6. Refunds

Due to the custom nature of our products, all sales are final, and no refunds are available after the initial consultation and deposit.

7. Confidentiality and Data Protection

We will process Personal Data in line with data protection laws and our Privacy Policy. The Author is responsible for the accuracy of the content provided, and we will not verify its authenticity. Personal Data provided will be used strictly for project purposes.
